

### Article I

## **Event Organizer**

Future Advanced Technologies Institute Brigádníků 44/2, 100 00 Prague 10, Czech Republic (Hereinafter "the Organizer")

#### Article II

## **Application Form**

- 1) The Application Form sent to the Organizer is binding for the Partner. The Organizer is entitled to decide whether the Application Form will be accepted, reduced or rejected, without obligation to give the reason of its decision.
- 2) The Partner undertakes to fulfil all obligations arising from its participation. Any changes are subject to a prior consent of the Organizer.

#### Article III

#### **Payment Terms and Conditions**

- 1) The Partnership fee and all services rendered must be paid by the due date stated on the invoice.
- 2) In case the fee is not paid by the due date stated on the invoice, the delay of the Partner is considered a material breach and the Organizer is entitled to withdraw from the Contract.

#### **Article IV**

#### **Final Provisions**

- 1) The Organiser has the right to change the venue, the date of the Event or to cancel the Event due to circumstances beyond its control ("force majeure"). In case such a situation arises, the Partner should be notified immediately. The Partner shall not be entitled to claim any compensation for damage sustained. The Organizer shall be entitled use the payments made by the Partner to cover the costs incurred. If possible, the Partner has a right to have the Organizer's obligations fulfilled at another suitable date, for which purpose the unconsumed part of the Partner's payments shall be used.
- 2) The Partner may make a complaint about the work and services provided by the Organiser without undue delay, but no later than before the end of the event, otherwise his right shall expire.
- 3) Unless stipulated otherwise herein and in cases of a breach of any provisions of the General Terms and Conditions, the Organizer shall be entitled to ban the Partner from further participation in the event. In such cases, the Partner shall not be entitled to any compensation of damages or reimbursement of the rent it has paid.
- 4) Unless otherwise stated in these Terms and Conditions and in case of a breach of any provision of the General Terms and Conditions, the Organiser is entitled to ban the Partner from further participation in the Event. In such cases, the Partner shall not be entitled to compensation for damages or to a refund of the amount paid.
